<b>What is the overall deductible?</b>	In-Network- \$3,500 Individual/\$7,000 Family Total. Out-of-Network- \$7,000 Individual/\$14,000 Family Total. Doesn't apply to In-Network preventive care. <u>Coinsurance</u> and <u>copayments</u> do not apply to the <u>deductible</u> .	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. <b>What is not included in the out-of-pocket limit?</b>	<u>Premiums</u> , <u>balance-billed</u> charges, health care this <u>plan</u> doesn't cover and penalties for failure to obtain <u>pre-authorization</u> for services. #### **Does this plan provide Minimum Essential Coverage? Yes**

If you don't have Minimum Essential Coverage for a month, you'll have to make a payment when you file your tax return unless you qualify for an exemption from the requirement that you have health coverage for that month.

#### **Does this plan meet the Minimum Value Standards? Yes**

If your plan doesn't meet the Minimum Value Standards, you may be eligible for a premium tax credit to help you pay for a plan through the Marketplace.
